



APPLICATION FOR ITINERANT DEALERS, PEDDLERS AND SOLICITORS PERMIT IN THE TOWN OF BEL AIR, MARYLAND

Any person engaging in the business of itinerant dealer, peddler or solicitor in the Town of Bel Air shall secure a license from the Town of Bel Air and comply with State of Maryland and Harford County licensing regulations and the Bel Air Town Code and fees. Prior to the issuance of any license by the Town of Bel Air, the applicant must present: business & auto insurance (if selling from a vehicle); a copy of the approved State of Maryland and Harford County licenses and permits; written proof of approval from the Harford County Health Officer, or his designee, when involved in the sale of produce or food items; if the request involves sales from private property (excluding door-to-door soliciting) - written proof of approval from the property owner. Activity is restricted to the areas indicated on the Itinerant Dealer and Peddler Map (see attached).
