# ADULT PROGRAM

Outpatient services for Adults with substance use, mental health, and co-occurring disorders

- Includes weekly group and individual therapy services: Substance Use, Mental Health and Dual Diagnosis Groups available
- Peer support
- Medication management
- Geriatric Program - comprehensive neurocognitive screenings provided
- Mental Health group for Females 60+ available

Intensive Outpatient Services for Adults

- Includes 9 hours of weekly substance use disorders group therapy, in addition to your individual therapist and care team



# YOUTH & ADOLESCENT PROGRAM

Outpatient services for youth and adolescents ages 10-17 with substance use, mental health, and co-occurring disorders.

- Includes individual therapy sessions and family sessions as needed
- Peer Support
- Medication Management

# LOCAL ADDICTIONS AUTHORITY

- Provides oversight and grant monitoring of all county-wide substance use initiatives, programs, and funding
- Oversees the distribution of Naloxone and provides training on the use of this life saving medication



- Works closely with Core Service Agency as the Local Behavioral Health Authority for Harford County
- Oversees grant-funded services provided through the Health Department Temporary Cash Assistance Program (works in conjunction with the Department of Social Services) and the Drug Court Program (works in conjunction with the district and circuit courts)
